## 2009 NRA Sponsorship Terms and Conditions

The following Terms and Conditions apply to all sponsorships of the various NRA competitions through the Sponsor Levels.

Submission of any materials or payments does not guarantee sponsorship of the event(s) selected. NRA shall notify each prospective sponsor of acceptance and official designation as sponsor of the individual event(s). NRA shall make every reasonable effort to approve all appropriate and complete sponsorship submissions on a first in time basis but final approval of any sponsorship will be made upon the sole determination of NRA. NRA reserves the right to reject any proposed sponsorship or cancel any sponsorship for which any payment(s), including submission of any products or merchandise, has not been timely received.

Official designation as a Sponsor shall not be construed to create an employer-employee relationship, partnership, sales agency, dealership, joint venture, or joint employer relationship between NRA and Sponsor or between NRA and any agent, servant, employee, subcontractor, or invitee of Sponsor. Sponsor agrees not to hold itself out as having any such relationship or status with NRA.

Initial payment is due at the time of the submitted application and failure to make payment with application may result in NRA selecting a different Sponsor or removal of the Sponsor as an Official Sponsor, including but not limited to the Sponsor losing any and all benefits of sponsorship. NRA reserves the right to remove any Sponsor as an Official Sponsor and, if NRA so exercises this right, NRA shall refund any amounts paid by Sponsor to sponsor any event set to take place after the date of removal.

Sponsor agrees to submit all information (including but not limited to logos, sponsor descriptions, advertising materials, and desired URL) by March 13, 2009. Sponsor agrees to submit all electronic images in high resolution and in eps, jpg, or tif formats.

Sponsor understands and agrees that no more than 40% of any sponsorship costs may be made in merchandise, if applicable. NRA agrees to use wholesale values in computing the merchandise total. Sponsor agrees to provide all merchandise donations on or before June 1, 2009. Platinum Sponsors agree to provide the required firearm(s) on or before June 1, 2009 to NRA.

All advertising, marketing, signage, and similar materials shall be provided by the Sponsor, as applicable, and are subject to the approval of NRA, including but not limited to placement and size restrictions and venue space availability as determined solely by NRA.

Sponsor shall indemnify, defend, and hold harmless NRA and its officers, directors, employees, and agents against and from any and all claims, liabilities, injuries, damages, costs, losses, or expenses, including any and all attorney's fees, arising out of or in any way related to any act or omission of Sponsor or the sponsorship of any and all events. Sponsor, upon notice from NRA, shall defend the same at Sponsor's expense by counsel reasonably satisfactory to NRA.

Sponsor agrees that any disputes arising out of or related to the sponsorship shall be governed by and construed under the laws of the Commonwealth of Virginia, or, if applicable, federal law. Sponsor further agrees that any legal proceedings arising out of or related to the sponsorship shall be maintained exclusively in courts sitting within the County of Prince William, the County of Fairfax or the City of Alexandria, in the Commonwealth of Virginia. Sponsor consents to and subjects it/him/herself to the personal jurisdiction of such courts and agrees that jurisdiction and venue for any such proceeding shall lie exclusively with such courts.
